## Friday, October 12, 2007

Greg Toll, Chair Minor Directorate called the meeting to order at 7:00 pm. Greg Toll then welcomed everyone to the Annual General Meeting.

Greg Toll, Chair spoke briefly explaining the purpose of tonight's meeting is to hear the Proposed changes to the BCLA Minor Directorate Policy and the Rationale for these changes to be voted on in the Saturday afternoon meeting. Greg Toll announced that there are speakers to explain what has taken place during the 2007 Season and what to look forward to for the 2008 Season.

Doug spoke briefly regarding the National program as he was the Head Coach – Peewee National Team.

Selection of team is very difficult to make especially when you are playing the teams from the East and how they are coached..

**Doug Wright – Vice Chair Minors, BCLOA** spoke briefly on the following: Doug began by welcoming Doug Clarke to the Coaches Association and is looking forward to working with him.

Doug oversees the training and development of Refs in the Province. There are 1,087 refs in the Province this number includes Senior Refs as well. There was a strong growth in Zone 3 and Zone 6 for Refs...

The Challenges for the 2007 Season –

- interesting session took place with Coaches at the Special Session
- Joint Community between Coaches/Officials.
- Suggestion that Coaches stand on the floor and be yelled at and then ask why Refs quit.

Hi-lights of the 2007 Season for Refs was the online support system that allowed Ref Reports to be done worked well, once all the bugs were worked out.

There is a lack of experienced level 2 and 3 Refs. Its time to recruit at the Level 2 and 3 as more Refs are becoming needed in this area.

Terrace organized a Female Box lacrosse Camp to build their female program.

Girls Field Lacrosse was a big goal for the lower mainland.

# BC Lacrosse Association – 2007 Proposed Changes to the BCLA Minor Directorate Operating Policy

Proposed by the Minor Directorate - Dave Wilkie, Vice-Chair, Minor Directorate moved, Keith Armstrong, Zone 3 Seconded *CARRIED* 

## Remove REGULATION 3: Commission Competition, 3.08 that currently reads:

3.02.1 To register these later players, the association will forward one copy of the player's registration form to the League Commissioner who will add the player's name to the appropriate team list and will forward the information to the BCLA Office for addition to their appropriate lists.

Re-Number 3.09 to 3.08

**Rationale**: Housekeeping. This policy was revised last year and is listed as 3.07.

#### **REGULATION 5:** Commission Competition, 5.03 currently reads:

5.03 In Commissions that form all leagues in PeeWee, Bantam and Midget Divisions, all movement of teams by the Commission must be completed by June 7<sup>th</sup>. After June 7<sup>th</sup>, no team shall be moved for league or Provincial Championships play.

## Amend REGULATION 5: Commission Competition, 5.03 that would read:

5.03 In Commissions that form all leagues in PeeWee, Bantam and Midget Divisions, all movement of teams by the Commission must be completed by June 7<sup>th</sup>. After June 7<sup>th</sup>, no team shall be moved for league or Provincial Championships play. In Commissions that have an interlocking A1 and A2 schedule for PeeWee, Bantam and Midget Divisions, all movement of these teams by the Commission must be completed by June 20<sup>th</sup>. After June 20<sup>th</sup>, no team shall be moved for league or Provincial Championship play.

**Rationale**: The Lower Mainland is attempting to have interlocking play between A1 and A2. Interlocking play will help develop players and the overall level of lacrosse within the province. It is our hope that extending the deadline will allow commissioners more time to access the competitiveness of teams. This date change would also help the Island

in assessing the ability to compete against lower mainland teams and give Island commissioners a better chance to assess their teams as well. The ultimate goal is to provide all players with a better chance to improve their overall skill level, and for coaches to be given more time to train their respective teams to compete at a higher level.

Bantam -2.5 years times the number of registered players except the 2

experienced players.

Example (PeeWee) 15 registered players

Total number of years of experience is 26 years:  $(15-2) \times 2 = 26$ .

This must be sent to the League Commissioner by May 7 of the playing year.

## Amend REGULATION 5: Commission Competition, 5.04 that would read:

5.04 In Midget, Bantam and PeeWee, where "C" leagues are formed, no association may declare a "C" calibre team with more playing experience than the following:

PeeWee - 2 years times the number of registered players except the 2 most

experienced players.

Bantam - 2.5 years times the number of registered players except the 2 most

experienced players.

Midget - 3 years times the number of registered players except the 2 most

experienced players.

Example (PeeWee) 15 registered players

Total number of years of experience is 26 years:  $(15-2) \times 2 = 26$ 

This must be sent to the League Commissioner by May 7<sup>th</sup> of the playing year, who must in turn notify the Association President if numbers are not in compliance.

**Rationale**: If an association has not been notified of their eligibility for C Provincials then the President cannot make the necessary changes to the roster. ### **REGULATION 8:** Moves, 8.02 currently reads:

8.02 If a player who has played the two previous consecutive seasons with the same association, other than the one where he/she current resides, and during that time, either met the release requirements described in Minor Directorate Regulation 8.07 or lived within that association's boundaries, the player is considered grandfathered with that association and has the option of signing with that association as a grandfathered player or registering with his/her new home association, where they currently reside.

### Amend REGULATION 8: Moves, 8.02 that would read:

8.02 If a player who has played the two previous consecutive seasons with the same association, and has met the requirements described in Minor Directorate Regulation 8.01, relocates to another association's boundaries, the player is considered grandfathered with the original association and has the option of signing with that association as a grandfathered player or registering with his/her new home association, where they currently reside.

**Rationale**: Associations that are building programs require the right to recall players that live within their boundaries, regardless of the fact they may have released a player for two consecutive years. This will reduce unfair player movement within the lower mainland. Player movement should only be acceptable under rule 8.07 and not for calibre.

In extenuating circumstances, with rationale, an Association may request and must receive authorization from the Minor Directorate to play at a lower level.

In zones where tiering does not take place, established Associations with four (4) or more years of playing experience, with more than thirty (30) players, in the same division excluding players with "0" experience (i.e., PeeWee, Bantam, Midget), the first declared team for the Provincial Championship must declare at an "A" level. In extenuating circumstances, with rationale, an Association may request and must receive authorization from the Minor Directorate to play at a lower level.

**Rationale**: In zones that run house leagues, the four-game rule rarely applies.

In addition, zones where tiering does not take place, established associations with four (4) or more years of playing experience with 5 or more teams in the same division, the first declared team for Provincial Championship must declare at the A1 Level. In extenuating circumstances, with rationale, an Association may request and must receive authorization from the Minor Directorate to play at a lower level.

In zones where tiering does take place, established associations with four (4) or more years of playing experience with 4 or more teams in the same division, the first declared team for Provincial Championship must declare at the A1 Level. In extenuating circumstances, with rationale, an Association may request and must receive authorization from the Minor Directorate to play at a lower level.

Rationale: The Province is struggling to have Provincials at A1 due to teams not declaring at that level even when they have 5 or more teams. This rule would balance the A1 and A2 program requiring more teams to play a higher calibre ball. This rule would see the lower mainland, and outlying regions declare more A1 teams. More minor athletes playing at the A1 level will give kids a greater opportunity for advancement in the game, creating opportunities in Provincial and National programs, getting the recognition they deserve. Given the lower mainland and Island have the ability to play within a tiered league, we should require associations to develop their programs, removing the focus of winning and establishing a mandate for development. This will leave a greater possibility of developing associations to compete at the A2 level to develop their players. This rule at the Minor Directorate level would then supersede the lower mainland and the Island, making the job of the commissioners easier with more established guidelines.

Pat Dobie, North Delta requested a count on the vote. Count was taken 57 against and 48 for. **Motion Defeated.** 

Proposed by Peter Frey, Lower Mainland Midget B Commissioner Carmen Schmidbauer, Zone 6 Director moved Myrna Cable, Prince George Minor Seconded – CARRIED WITH AMENDMENT

Add new REGULATION 13: National Championships that would read:

- 13.01 The Minor Directorate will be responsible for the selection of teams entering National Championship Competition.
- 13.02 The Minor Directorate will appoint, from its members, a committee to look into all aspects of our National Team commitment and report back to the Minor Directorate every year in January.
- 13.03 The Minor Directorate will appoint one member of the Minor Directorate to be on the National Championship Committee of the Canadian Lacrosse Association.

Re-number Regulations 14 to 21.

Pete Frey, Zone 5 moved amendment Keith Armstrong, Zone 3 Director Seconded **AMENDMENT Read as follows: - CARRIED** 

- 13.01 The Minor Directorate will be responsible for the National Championship Competition representative for teams.
- 13.02 A committee, made up of members of the minor directorate, will oversee all aspects of our National Teams, and report back to this minor Directorate in January of each year.

13.03 The minor directorate will *recommend* from it's membership a person to attend all meetings called by the CLA National Championship Committee to the BCLA Executive.

#### Entire Motion – CARRIED WITH AMENDMENT

#### Re-number Regulations to 14 to 21.

**Rationale**: Nowhere in any of the operating policies, except for the Coaches Operating Policy, are there rules and regulations governing National Championships for Minor teams. This regulation will give minor associations a way to have input into the make-up of teams and the rules and regulations governing those teams.

#### **REGULATION 20:** Summer Games, 20.06 currently reads:

- 20.06 (a) The Minor Directorate will advise the Provincial Advisor as to what division and calibre will be participating, ensuring that the choice will allow representation from all zones.
  - (b) The Zone Directors will declare the team representing the zone as per B.C. Summer Game deadlines.

#### Amend REGULATION 20: Summer Games, 20.06 that would read:

- 20.06 (a) The Minor Directorate will advise the Provincial Advisor as to what division and calibre will be participating, ensuring that the choice will allow representation from all zones.
  - (b) The Zone Directors will work with the Presidents of the Associations in their zones to insure that all players willing to participate in the Summer Games team are informed of the player application procedures and will work with the Coaching Zone Director to schedule sufficient team tryouts required for declaring the team representing the zone as per BC Summer Game deadlines.
  - (c) The Zone Directors are responsible to enter the final team roster and coaches per BC Summer Games policy into the BC Summer Games online registration database by the date determined by the Provincial Advisor each year of the Games.

- (d) The Zone Directors are responsible to ensure that all monies to register teams with BC Summer Games and any Jersey fees are collected and into the BCLA office at least 7 days before the Summer Games registration deadline.
- (e) The Provincial Advisor is responsible to ensure that all Officials (both referees and other official Representatives) are entered into the BC Summer Games Registration Database per the BC Summer Games deadlines.
- (f) The Provincial Advisor is responsible to ensure that all Players, Coaches and Officials are registered with the BCLA in the current year of the games and have met any criteria of participation required by the BC Summer Games. This must be verified in the Online Database before the deadline date set by the BC Summer Games.

**Rationale**: This to ensure that new procedures to register players for Summer Games online are completed on time by the responsible party per the BC Summer Games Agreement signed by the BCLA on behalf of the Minor Directorate.

Proposed by the Minor Directorate Dave Wilkie, Vice-Chair Minor Directorate moved Shawn House, Chair Female Box Lacrosse Seconded - CARRIED

- June Mid month\* is the deadline for Provincial declaration forms to be received at the BCLA office, not to be confused with the May 31 team list requirement. The declaration form is separate and additional.
