VC – Mens Field Report

This year all clinics were done via Zoom. Thank you to Lee Brien, Jody Weatherby and Doug Wright for the many planning and trial sessions that were completed prior to the certification clinics. Thank you to all of the clinicians who adapted their teaching to the online platform. Thank you to all of the officials who attended the certification clinics despite the uncertainty of what the season would look like.

A total of 124 officials were certified this year:

- 67 Entry Level
- 32 Level 2
- 25 Level 3,4,5

The RTL modified rules presented many challenges in the planning of the clinic material as they were constantly being updated right up until the first clinic, again during the clinic schedule followed by further changes during the season. When questions from the Officials group were asked regarding clarification or changing the playing rules, before the clinics started, they were all dismissed without action. It was only until the teams and league representatives asked the same questions that the rules were changed. This resulted in officials being taught one set of rules at their certification clinic and then having to learn and understand different rules based on written clarifications and on field experience afterwards.

The Field lacrosse officials group look forward to returning to the classroom certification setting next season as we feel the value of in person teaching and the ability to interact with the officials is a far better learning environment than what can be achieved online.

RIC Report for 2020

The 2020 season was unprecedented and shall go on record as the year of a worldwide pandemic, which brought the deadly disease and a world of uncertainty. We only managed to play six weeks on paper, but at the very last moment, week five was cancelled due to Covid 19 outbreaks. The last minute cancellation meant only five weeks of active play, but referees were assigned for six weeks.

The referees went through a significant change of learning by no longer being certified in a classroom setting. All the officials attended their levels on an online platform which was challenging for both instructors and students. As the season progressed in the short season, so did the Covid compliant rules. These new rules required lots of flexibility until we thought we got it right.

Some policies were totally out of our control as we had to adhere to Provincial Health Orders which meant officials could not enter other Health Authority Zones. This order meant officials were stranded in their home zones and could not officiate at other associations.

Many officials decided to remove themselves from working games this year, mainly to protect elderly family members from contamination while others had to self isolate and enter into quarantine. These actions reduced the officials pool of referees which was challenging to fill games.

I want to thank all the referees for the patience, diligence and understanding, as the ever-fluctuating rules caused lots of frustration.

Special shout out to Angie Wolf for the thankless work she put into making a revolving schedule week in and week out.

Team B.C. Field Lacrosse Special Session – Report

We had our male and female athletes that were identified to teams in 2020 participate in the inaugural Team BC Field Lacrosse Fall Training Program. This training allowed for our athletes to safely train together in a High Performance Environment. We were able to train for three months before further restrictions were put in place limiting non-essential travel throughout the province.

The Annual NCAA National Letter of Intent Signing Event that normally occurs at the BCLA office was not able to occur in person this year due to COVID-19 restrictions. We celebrated our athletes (12 females - 17 males) virtually as they received their Official Scholarship Offers to attend a variety of Colleges and Universities in the United States. Team BC Field Lacrosse Program currently has over 100 Female and Male athletes competing at the collegiate level.

I am very pleased with the growth and development of both our Female and Male Lacrosse Coaches and Athletes! The Women's U19 Nationals and the Men's U18/U15 Nationals are scheduled to take place this summer in Alberta and Quebec respectively.
