



2018 PROPOSED CHANGES TO THE BC LACROSSE COACHES OPERATING POLICY

Proposed by Savanna Smith, Vancouver Women's Field Chair

REGULATION 1: MEMBERSHIP, 1.02 (a) currently reads:

1.02 To be an active member of the BCLCG, a Coach must:

- (a) Be registered with the BCLA through the BCLCG utilizing one of the following forms:
Form 100B – Box Lacrosse
Form 100M – Youth/Men's Field Lacrosse
Form 100W – Women's Field Lacrosse

Forms with fees as outlined in Appendix "B" of the BCLA Operating Policy must be received by the following dates in the current coaching year:

Form 100B – All Minor Box Coaches	May 1
Form 100M – All Youth/Men's Field Lacrosse Coaches	Oct 1
Form 100B – All Senior Box Coaches	April 20
Form 100W – All Women's Field Lacrosse Coaches	May 1

Amend REGULATION 1: MEMBERSHIP, 1.02 (a) that would read:

1.02 To be an active member of the BCLCG, a Coach must:

- (a) Be registered with the BCLA through the BCLCG utilizing one of the following forms:
Form 100B – Box Lacrosse
Form 100M – Youth *and Female Youth*/Men's Field Lacrosse
Form 100W – Women's Field Lacrosse

Forms with fees as outlined in Appendix "B" of the BCLA Operating Policy must be received by the following dates in the current coaching year:

Form 100B – All Minor Box Coaches	May 1
Form 100M – All Youth <i>and Female Youth</i> /Men's Field Lacrosse Coaches	Oct 1
Form 100B – All Senior Box Coaches	April 20
Form 100W – All Women's Field Lacrosse Coaches	May 1

Rationale: There are two separate seasons of play for Women's or Female Youth Field Lacrosse in BC. The Youth play in the fall from September to February. The Women's teams play March to July. There should be two separate deadlines, as the youth coaches would be in the fall and usually not picked or registered to coach until August or September making it impossible to have the 100W form in for the fall playing season.

This motion affects 2.03 (a), 7.03 (a)(b), and 11.03 (b)(i)(ii)

REGULATION 7: BENCH RULES, 7.03 (a) currently reads:

7.03 (a) All bench personnel must meet the following requirements to participate in any BCLA sanctioned games in the Novice division and below:

Amend REGULATION 7: BENCH RULES, 7.03 (a) that would read:

7.03 (a) All bench personnel must meet the following requirements to participate in any BCLA sanctioned games in the Novice division and below *(Box) and U9 and below (Field)*:

Rationale: Housekeeping as both female and male field lacrosse have age groups listed in 7.03(b) but not in 7.03(a).
