6. **Proposed Amendments**

Gord: Rule that the meeting proceed with all the proposed amendments and let the agenda stand as is.

Motion: That the proposed amendments are out of order at this time. It was moved by Beth McLucus, seconded by Tom Kellet that the Minor Directorate reports be accepted as circulated.

Noted: 44 votes in favor and 48 not in favor. Voted required a 2/3 vote for majority. *Motion is out of order. DEFEATED.*

REGULATION 1: STRUCTURE, 1.01 – COMMISSION CHAIRS currently reads:

Commission Chairs

- (a) Communication link between the Minor Directorate (through Zone Directors) and their Associations
- (b) Ensure good communications with the Executive and their Associations and possibly with players and parents
- (c) Maintain a good working relationship with all Associations within their Commission
- (d) Responsible to Minor Directorate and all Associations within the Commission
- (e) Responsible for schedule and guidelines for league play and Provincial play-offs in their Commission
- (f) Select their Commissioners, as per Commission Operating Policy and acts as Head Commissioner
- (g) First level of appeal on all matters within their Commission (jurisdiction, players discipline and player movement)
- (h) When player registrations dictate and local associations agree, is able to suggest cross association boundary teams within their league and obtain approval from the Minor Directorate as needed.

Amend REGULATION 1: STRUCTURE, 1.01 – COMMISISON CHAIRS that would read:

Commission Chairs

- (a) Communication link between the Minor Directorate (through Zone Directors) and their Associations
- (b) Ensure good communications with the Executive and their Associations and possibly with players and parents
- (c) Maintain a good working relationship with all Associations within their Commission
- (d) Responsible to Minor Directorate and all Associations within the Commission
- (e) Responsible for schedule and guidelines for league play and Provincial play-offs in their Commission
- (f) Select their Commissioners, as per Commission Operating Policy and acts as Head Commissioner
- (g) First level of appeal on all matters within their Commission (jurisdiction, players discipline and player movement)

<u>Rationale</u>: Policy has been vague on who is responsible for decisions on player release requests within commissions. There have been variations on ow this was done within different commissions. This is meant to clarify that the decision on player release requests lies with the commission chair together with the elected commission executive.

REGULATION 2: PLAYING DIVISIONS, 2.01 currently reads:

2.01 The ages of players prior to January 1 of each playing year shall be as follows:

As per General Operating Policy, Regulation 9, the playing year shall be from January 1 to December 31 in any calendar year.

Amend REGULATION 2: PLAYING DIVISIONS, 2.01 that would read:

2.01 The ages of players prior to January 1 of each playing year shall be as follows:

As per General Operating Policy, Regulation 9, the playing year shall be from January 1 to December 31 in any calendar year.

Rationale: To comply with recent changes to CLA policy in Midget (17U) aged players.

Motion of out order

Proposed by Greg Toll, BCLA Vice President - Operations

Add new REGULATION 2.02: PLAYING DIVISIONS, 2.02 that would read:

2.02 All midget aged players that will be 17 years old between January 1 and December 31 of their current registration year, will be permitted to choose to play as a midget player or to move up to play in the junior division. This decision must be made prior to registration with a minor or junior team. Once the decision is made, there will be no allowances for reversing this choice at any time. This includes all lacrosse activities (tryouts, training, exhibition games, etc). Any exceptions or appeals will be dealt with by the Jurisdiction Committee. Call ups from minor to junior will continue to be permitted as currently policy states.

<u>Rationale</u>: To comply with recent changes to CLA policy in Midget (17U) aged players and outline players choice has to be made before registration with either the Midgets or the Juniors.

Motion of out order

Proposed by Garrett Ungaro, Coquitlam Minor Lacrosse - President

Add new REGULATION 5.05 (b): COMMISSION COMPETITION, 5.05 (b) that would read:

5.05 (b) In Midget, where there is a 3 year age group, when Associations are declaring an A1 team, no more than 5 (five) rostered players may be 3rd year players. No more than 2 (two) 3rd year players may be called up to Midget A1 at any time for league, playoff or Provincial games. 3rd year players must be identified on all game sheets with the label "OA" to indicate clearly which players are 3rd year players.

Associations may request an exemption from their Local Commission, Minor Directorate and Senior Directorate in that order, to exceed 5 (five) 3^{rd} year players. If an Association has only 1 declared team in Midget, the limitation on number of 3^{rd} year players is waived with no exemption required.

<u>Rationale</u>: With the introduction of a 3 year age group in Midget, large Associations could have a significant advantage in a specific year with a large group of registrants becoming 3rd year players. If that Association fields an A1 team with 15 3rd year players, the rest of the league will suffer or cause teams not to declare at the A1 level. The whole goal of a 3 year Midget program as stated by the BCLA is to capture the odd player who feels they aren't ready to play Junior. This gives those players a place to play in Midget while keeping large and small Associations on an even playing field and not stacking an A1 team with 3rd year players. The goal is participation for smaller or less-developed 3rd year players.

The wording also doesn't punish smaller Associations with only 1 Midget team and allows them to field a team with whatever players are registered to compete at the A1 level.

Should this motion pass the current 5.05 will be renumbered to 5.05 (a)

REGULATION 7: MOVEMENT – SENIOR BOX TO MINOR, 7.02 currently reads:

7.02 **Criteria for Approval:**

- (a) Players must be within two (2) years of Midget eligibility.
- (b) Cannot be from an area where there traditionally is a Junior team already registered. When there is no Juvenile Team: over-age Female Box Players will be permitted to play down; male Box Players with two years of experience or less will be permitted to play down.
- (c-i) In Zones where a Junior team is available within a two hour drive (as defined by Google Maps) from the player's home: Cannot be more than two (2) over-age players per team unless the Minor Association is less than two (2) years old. If the Association is less than two (2) years old, then the maximum number will be four (4) players.
- (c-ii) In Zones where a Junior team is NOT available within a two hour drive (as defined by Google Maps) from the player's home: Cannot be more than four (4) over-age players per team.
- (d) Players granted an opportunity to play down, will have their players statistics reviewed during the season of play (for penalties, scoring, etc). The Minor Directorate will communicate the names of players playing down to the League Commissioners, who will need to keep statistics and report to the Minor Directorate any anomalies seen during review of game sheets, or at a game. Upon review by the Minor Directorate, a previously approved application to play down from Senior to Minor can be reversed at any time during the season of play.
- (b) An over-age player MAY be eligible for playdowns, playoffs, Zone/Commission Championships or for Provincial Championships play. The Minor Directorate determination will include at least the following: penalties review, scoring, participation.
- **<u>NOTE</u>**: Applications for movement will be reviewed on a case-by-case basis, taking a player's size and skill level into consideration.

Amend REGULATION 7: MOVEMENT – SENIOR BOX TO MINOR, 7.02 that would read:

7.02 **Criteria for Approval:**

- (a) Players must be within *one* (1) year of Midget eligibility.
- (b) Cannot be from an area where there traditionally is a Junior team already registered. When there is no Juvenile Team: over-age Female Box Players will be permitted to play down; male Box Players with two years of experience or less will be permitted to play down.
- (c-i) In Zones where a Junior team is available within a two hour drive (as defined by Google Maps) from the player's home: Cannot be more than two (2) over-age players per team unless the Minor Association is less than two (2) years old. If the Association is less than two (2) years old, then the maximum number will be four (4) players.
- (c-ii) In Zones where a Junior team is NOT available within a two hour drive (as defined by Google Maps) from the player's home: Cannot be more than four (4) over-age players per team.
- (d) Players granted an opportunity to play down, will have their players statistics reviewed during the season of play (for penalties, scoring, etc). The Minor



Directorate will communicate the names of players playing down to the League Commissioners, who will need to keep statistics and report to the Minor Directorate any anomalies seen

during review of game sheets, or at a game. Upon review by the Minor Directorate, a previously approved application to play down from Senior to Minor can be reversed at any time during the season of play.

- (c) An over-age player MAY be eligible for playdowns, playoffs, Zone/Commission Championships or for Provincial Championships play. The Minor Directorate determination will include at least the following: penalties review, scoring, participation.
- **<u>NOTE</u>**: Applications for movement will be reviewed on a case-by-case basis, taking a player's size and skill level into consideration.

<u>Rationale</u>: To bring the play down request from senior to minor in line with CLA changes to midget age players (now 17U).

Motion of out order

Proposed by Gord McIntosh, BCLA Minor Directorate Chair

REGULATION 8: MOVES, 8.05 currently reads:

8.05 Where there is no team available within the player's age group or in the case of a Female player, a team within the player's age group in the Female league, the player may play for another association with written release from the player's home association and written approval by their local Commission for the current playing season only. (This release is not counted as a grandfathering year.) The player will be placed where the *local* Commission feels it would be in the best interest of the League and then the player.

In cases where there is no Commission, and the player is requesting a release into another Commission/Zone, the President of the other Association where the player is requesting a release from must also approve of this release. If the release is granted/approved, the player will be placed by the Commission/Zone the player is being released to and will be placed where the Commission feels it would be in the best interest of the League and then the player. If the release is not granted/approved, the player can appeal the decision with the Minor Directorate.

Amend REGULATION 8: MOVES, 8.05 that would read:

8.05 Where there is no team available within the player's age group or in the case of a Female player, a team within the player's age group in the Female league, the player may play for another association with written release from the player's home association and written approval by their local Commission for the current playing season only. (This release is not counted as a grandfathering year.) The player will be placed where the Commission *chair and elected commission executive* feels it would be in the best interest of the League and then the player.

In cases where there is no Commission, and the player is requesting a release into another Commission/Zone, the President of the other Association where the player is requesting a release from must also approve of this release. If the release is granted/approved, the player will be placed by the Commission/Zone the player is being released to and will be placed where the Commission *chair and elected commission executive* feels it would be in the best



interest of the League and then the player. If the release is not granted/approved, the player can appeal the decision with the Minor Directorate.

<u>Rationale</u>: Policy has been vague on who is responsible for decisions on player release requests and moves within commissions. There have been variations on how this was done within different commissions. This is meant to clarify that the decision on player release requests lies with the commission chair together with the elected commission executive.

REGULATION 8: MOVES, 8.10 currently reads:

8.10 For those players attending a specialized school (i.e., hockey school) that is far enough from their principle residence that they must live away from their immediate family and be billeted, will provide proof of school attendance in way of a school transcript. The billeted address will be recorded in the comments section in the registration database if the home address is being used as the address. The player will be placed where the commission feels it would be in the best interest of the league and then the player. At the end of the school year, if the player wishes to move back to the player's original home association before the June 20th deadline, 8.06 shall apply.

Amend REGULATION 8: MOVES, 8.10 that would read:

8.10 For those players attending a specialized school (i.e., hockey school) that is far enough from their principle residence that they must live away from their immediate family and be billeted, will provide proof of school attendance in way of a school transcript. The billeted address will be recorded in the comments section in the registration database if the home address is being used as the address. The player will be placed where the commission *chair and elected commission executive* feels it would be in the best interest of the league and then the player. At the end of the school year, if the player wishes to move back to the player's original home association before the June 20th deadline, 8.06 shall apply.

<u>Rationale</u>: Policy has been vague on who is responsible for decisions on player release requests and moves within commissions. There have been variations on how this was done within different commissions. This is meant to clarify that the decision on player release requests lies with the commission chair together with the elected commission executive.

Motion of out order

Proposed by Gord McIntosh, BCLA Minor Directorate Chair

REGULATION 10: TEAM SIZE, 10.01 currently reads:

- 10.01 (a) Per Rule 14 of the CLA Rulebook, no Midget, Bantam, PeeWee, Novice, Tyke or Mini- Tyke team (mixed Minor or Female Box) under the jurisdiction of the Minor Directorate shall not have more than 20 signed players, except with special permission of the Commission. Such exceptions shall be ratified by the Minor Directorate. Any team carrying more than 20 players will only be permitted to bring 20 players to Provincials and will not be permitted to use call-up players for the Provincial Tournament.
 - (b) No Female Junior team, under the jurisdiction of the Minor Directorate shall be permitted to sign more than 25 players. Only 20 players (18 runners and 2 goalies)



will be permitted to be listed on a game sheet for league and tournament play. Only 20 players will be permitted to be verified for League Playdowns/Championships and Provincial Tournament play.

Amend REGULATION 10: TEAM SIZE, 10.01 that would read:

- 10.01 (a) Per Rule 14 of the CLA Rulebook, no Midget, Bantam, PeeWee, Novice, Tyke or Mini- Tyke team (mixed Minor or Female Box) under the jurisdiction of the Minor Directorate shall not have more than 22 signed players, except with special permission of the Commission. Such exceptions shall be ratified by the Minor Directorate. Any team carrying more than 22 players will only be permitted to bring 20 players to Provincials and will not be permitted to use call-up players for the Provincial Tournament.
 - No Female Junior team, under the jurisdiction of the Minor Directorate shall be permitted to sign more than 25 players. Only 20 players (18 runners and 2 goalies) will be permitted to be listed on a game sheet for league and tournament play. Only 22 players will be permitted to be verified for League Playdowns/Championships and Provincial Tournament play.

<u>Rationale</u>: This policy was changed in 2019 from 22 players to 20 in the hopes of getting associations to increase the number of teams. This did not have the desired effect. The MD had 17 requests for oversize teams in 2020, of which all were approved. Each request had a valid and understandable reason for the request with the majority being from outside the lower mainland where geographies were a challenge.

Motion of out order

7. Election of Officers. Greg Toll conducted the elections.

- a) Chair (Two-Year Term) Gordon McIntosh was elected. The Minor Directorate, Secretary was asked to case one ballot.
- b) Secretary (Two-Year Term) Dee Bowley-Cowan was elected. Chair, Minor VP Minor Directorate was asked to cast one ballot.

It was moved by Pam Mason, seconded by John Stevens and that the Minor Directorate Secretary destroy the ballots. CARRIED.
