### c) Field Directorate – Beth McLucas

Special Session was in April 2023. We had 2 positions up – would like to thank Trish Keizer and Kelly Ohlmann for their time spent with the Field Directorate. ### d) BC Lacrosse Coaches Group - Russ Sheppard

There are revisions to the Coach's manual – for example the workbook for level 2 is changing, going to more of a portfolio process. A new manual from Lacrosse Canada is coming out– working with the group to have in-put on how that will look and how the rollout will happen.

Learning facilitators continue to be a problem, we don't have enough. Require/ask clubs to identify members within to be candidates. We have limited spots and often registered coaches don't show up which take up spots for coaches that need and want to attend. This must be a partnership with the club. After a meeting with the Coaches Technical Group one last thing – we are consistently being looked upon as the disciplinary board, which is not our function. We are asking the clubs to police their coaches and get them in check.

We spearheaded the "Play Book" Series – online sessions for field, box, female. Great facilitators offering great training. Coaches are required to track their professional development – please reach out if you don't know how to. It is required before you become noncompliant.

Will be reaching out to clubs looking for help with the Six's -lots of technical information needed to grow the game.

We had elections – Dan Chetner is the new Vice Chair. No questions asked.

# e) BC Lacrosse Officials Group – Andy Watson

Biggest issues continue to grasp – abuse, recruitment, retention, and regional development of our officials. We had great sessions across the board, and it will take all lacrosse approach and everyone in the room to part of the solution moving forward. A few changes in the roles Doug Wright has returned as the Chair, I (Andy Watson) will be moving to the Vice Chair – Sr Box. Cameron Anderson has stepped in as the Secretary. Thank you to Sean Lehman as the past VC Sr Box and Andrew Corbould for your 30 years as Secretary/Treasurer. No questions asked

### 11. <u>New Business</u>

### a) <u>Registration Fee Increase</u>

Lacrosse Canada will be increasing their registration fees from \$4/pp to \$10/pp this coming year and then again to \$15/pp next year. This will be reflected within the BCLA fee so wanted to get the information out to associations that are getting ready for their upcoming box season.

# b) Auditing BCLA Appeals – Wuilbert Jaramillo

It was moved by Wuilbert Jaramillo, seconded by Tim Frost that appeals BCLA has done in the last two years across all different directorates be audited.

**Rationale**: Commissions/Associations are finding out that disciplinary rulings are being overturned without any kind of communication leading to such decisions. There has not been a clear view of the process and timelines followed in those instances. As an institution with such clear policies to handle appeals and disciplinary rulings, it is necessary to take a look in depth on how appeals have been done. These disciplinary rulings/measures are to protect our members (i.e., coaches, players, referees, volunteers). Without any visibility/communication on overturned appeals, it is really difficult for commissions/associations to know what is going on as they are left in the dark. Appeals that overturn the original disciplinary rulings not communicated to the parties involved (i.e., commissions and/or associations), create unnecessary stress and volatile/dangerous situations. This audit aims to produce the process followed in each appeal, which in turn will provide transparency to the membership on this specific process. This also will highlight any possible anomalies that might have happened during the appeal process, and hence it will produce the appropriate corrective measures where applicable.

Discussion was had, not enough information was provided for the members to make an informed decision.

# c) Doug Wright – Chair of the Officials Group

We are approaching a crisis point in our sport in regard to our officials. We are losing officials at a rate we cannot sustain—there are a number of reasons but abuse being the greatest threat. I am asking for help in looking for solutions. We are doing our best to train our officials about abuse but for our new officials they are intimidated and are often struggling to make calls or don't make them at all. We are asking the clubs to support their officials – we need you to stand behind them and have their backs when they are making tough calls. It's hard for 15-year-olds to toss out adults. Currently we are short on level 2 officials – will be recruiting various ways to combat this issue. If you have any ideas, I welcome the opportunity to discuss it. Please reach out any time.
