6. New Business

- a. Dennis Quigley next steps in implementing the 3-man system
 - Discussion about push for the 3-man system (3 referee/person language should be used)
 Lee would recommend that the executive continue to push this forward
 - Doug main problem is the number of officials who are going to be available to officiate. Takes time to develop officials (2-4 years) before they can be put into games
 - a. Need to look from bottom up, start at PeeWee level and dramatically expand the number of officials
 - b. We are consistently short of officials so it make sthe 3-man system impractical in many areas
 - c. WLA using the 3-man system resulted in too many officials being pushed up to far/too fast
 - i. Pulled officials form the other senior leagues
 - d. Support the system but we need more referees
 - ii. Dennis Coaches supported 3-man system in today's meeting
 - iii. Tyson need to pull in parents and coaches to increase discipline to reduce referee abuse and numbers may go up
 - iv. Meaghan official abuse at the minor level from managers/coaches and fans need to increase suspensions
 - 1. Best games to referee came earlier this season when the fans weren't allowed
 - v. Sean did have discussion prior to games at Junior A about trying it this year but couldn't be due to lack of numbers
 - 1. Stated in my report we won't have enough officials to cover games if leagues impose 3-man system
 - 2. Other sports are also short on officials
 - vi. Joe hard to bring up the numbers unless we start at the bottom
 - 1. Impact of other jobs that pay more than refereeing should we be looking to increase fees?
 - 2. Abuse of officials is impacting kids staying
 - vii. Ideally, we'd like to do it but number of officials dictates an inability
 - viii. Doug are minor clubs in supportive of increasing referee costs by 50% to begin the development of officials in this system??
 - 1. Lee last 2 years of putting the idea out there, some bigger associations were for it, but varied by association
 - ix. Andy can we collect evidence from all areas of the province to determine resource level.
 - 1. Will be a challenge in other provinces too.
- b. Referee abuse Wilson can we revisit JOCAP around abuse
 - i. Actions of referee abusers need to be dealt with
 - ii. Rob Arden has worked hard with coaches, but referee is already gone and won't return to officiate
 - 1. Retroactive discipline is not working
 - iii. Lee we need to help referees make the abuse call
 - 1. Can't be an after the fact call
 - iv. Joe younger officials are intimidated without support from older officials or adults
 1. Role of the Head Referee to support officials training needed
