

Junior B1 Commissioner Report

This year we had a request from two clubs about adding teams to our league.

As we didn't have anything written in our league agreement all governors agree to hold off allowing them into our league this past season, but would add information into the league agreement and they could apply for this coming year.

Our season started 26 April and we had a 10 week schedule with Play downs starting 6th July. 1 week later.

We had a few suspensions, but no carry overs.

We had a few games cancelled due to not enough officials, also our official cost went up as we approved a \$10 across the board for Lower main land officials, which we accounted for, but what we didn't account for was the extra for officials travelling from Island to do games on mainland cost were nearly \$300 for 1 game and we had a few like this. We will need to revisit this for next year.

We ended up having to hold off 1 week due to an issue with one team and an appeal. The league won the appeal, but because of the timing we had teams who had now qualified for play downs drop out as they had players away prior to the appeal decision. The team who lost the appeal ended up now playing in play off but lost in the 1st round. We did ask the Interior if they could move the Provincials 1 week ahead since Founders was later. They couldn't. So we had to shorten our final playoff series from 5 games to 3.

Coquitlam ended up being the League champions.

Victoria Shamrocks ended up winning our play downs this year and had to travel over the August long weekend to play the Interior team. Once again our team won the 2 games and once again our governors feel that the Interior teams aren't B1 teams.

As Victoria won the provincials they head off to Founders to represent BC in Hamilton.

We did have some issues with our website, which we got sorted out after we realized it was giving points for a loss during OT.

We already have had a club inquiry about coming into our league for next year, which we will discuss at our AGM.

As of yet we have not set a date for our AGM but it will be sometime in November.

THOMPSON OKANAGAN JUNIOR LACROSSE LEAGUE - BT1

The 2024 season for the Thompson Okanagan Junior Lacrosse League (TOJLL) there were strong wins and difficult challenges.

Kamloops Venom defended their TOJLL championship and went on to host the Victoria Shamrocks. We congratulate the Victoria Shamrocks on their successes at the Founders Cup in Hamilton.

The TOJLL 2024 season allowed for the expansion of our program to the Kootenays with the inclusion of the Cranbrook Black Wolves on a trial season. The Black Wolves were the BC Junior B Teir 2 winners from the 2023 season.

Though there are distance challenges in regard to the location of the Cranbrook in the Kootenays, 1200KM round trip from the farthest TOJLL team. This was addressed by playing Saturday night and Sunday morning games both as the away team and the home team. With a young team Cranbrook grew stronger throughout the season as more of their older players returned from school. The experience gained for their U17 players given the opportunity to play with the team will speak volumes for the quality of players that they have moving up.

With the success of the season, Cranbrook has now been accepted as a TOJLL member, we look forward to many seasons with them moving forward. Expansion interest has also been expressed by Williams Lake and West Kootenay; at this time no movement has been made to adding them for the 2025 season.

The excitement of adding Cranbrook to expand our league was quelled by the disappointment that Armstrong was unable to field a team for the season. The closeness and intertwining of the boundaries for the minor and junior teams in the region has blurred the lines regards to player registration. With hold outs, misinformation, and miss communication led to unclarity for the participants.

With Armstrong unable to field a junior lacrosse team, Vernon had an oversized roster in which players were signed and unsigned throughout the season to get them playing time. I have been involved with the Thompson Okanagan Minor Box Lacrosse Commission (TOBLC) for 13 years, during that time there has been one (1) request to play from Senior to Minor in 2017, where a brand new 16-year-old player tried Field Lacrosse and then wanted to play a season of Box Lacrosse. In 2024, there were five (5) requests that were brought to TOMBLC by North Okanagan Minor Lacrosse Association (NOMLA) by players that wanted to play down to minor as they had no ability to play Junior. All five players had previous lacrosse experience and only one with extraordinary circumstances was approved for minor participation. Four (4) junior aged players were unable to play on a team for their home region. Speaking with the president for NOMLA there were additional players who's request he did not even bring forward to the TOMBLC for discussion given the previous denial by TOMBLC.

Minor Lacrosse for the area is increasing and U17 teams are growing and increasing, with that the growth and support of junior teams needs to continue. Smaller team sizes, such as South Okanagan and Cranbrook that utilize the development of the U17 players for their Minor teams appear to lead to stronger commitment at the junior levels from the players.

THOMPSON OKANAGAN JUNIOR LACROSSE LEAGUE - BT1

On the floor play was fast this year, with more emphasis on the game rather than the fighting, which was great to see. Less suspensions were issued than in the previous year, a great move forward! Lacrosse is a physical game with big legal hits, the players keeping it within the game play is great to see.

A negative for the season is the failure of the governors/teams to support the officials. Officials are a limited resource in the area, with eight officials for the 70+ games that were played between the Junior and Senior games this season. Many TOJLL games are videoed by the teams and the officials have requested game tape from teams to develop learning and missed calls. This opportunity to develop and increase the skills of the officials is not always supported when the Head Official is not being provided with access to the videos of play. However, the vilification of the officials was shared without hesitancy when errors were made. There is no success in this pathway.

Sitting at a game where not only the officials were being yelled at for a missed call, but I was also yelled at for not "doing something about it", "not caring about the players on the floor". This specific situation the official knew that he had missed an action behind the play but could only make a call based on what he saw. What he missed was my son being hit from behind in the back of the head, what he saw and called was the response that got. If team representatives have no hesitancy on projecting disdain on me as commissioner/parent, I understand completely why officials choose not to return when this is projected to them on the floor. Providing video to the referees after games to learn how they can better position themselves during games so that they are not missing crucial interactions. If they happen to see shady things to watch for, we then are producing a better quality of play.

I have stepped down from the role as Commissioner for the TOJLL and I wish them the best of luck in the future.

As a special note, the season was preceded by a tragic loss to the lacrosse community. Chris Baker, a player from North Shore, lost his life in an incomprehensible accident. With the support of the League and Chris's family an award was created to honour him and recognize those who carry the same spirit both in all that they do in the game. The inaugural winner was Zachary Goulet from the Valley Sturgeon as chosen by the North Shore Lacrosse Club and the Baker Family.

2024 - Vice-Chair Senior Box Lacrosse - Year-End Report

Sept. 8, 2024

In my year serving in as vice-chair of senior box lacrosse officiating for the BC Lacrosse Officials Technical Support Group (BCLOTSG), I was again humbled by the amount of work our leadership team has and continues to put in each and every year. Of significant note, there are a number of things emerging and being added to this and other volunteer portfolios that are making it increasingly difficult to fulfill the obligations of the role effectively. Due to demands professionally and with other volunteer commitments, I am not seeking re-election as I don't have the critical time required to be effective in this role. I will, however, be happy to support any incoming vice-char of senior box lacrosse as time allows/permits.

I want to extend particular thanks to Doug Wright who took over from me as chair of officiating — it's a particularly challenging role and Doug has done well to help lead our group. I also extend my thanks to Sean Lehman, the outgoing Vice-Chair, Senior Box Lacrosse, for his efforts in this role before me for six years.

In our third post-pandemic season, we continued to face challenges around staffing. This is going to become even more critical in the years ahead. A shortage of officials – particularly at the L3, L4 and L5 (aka senior) levels – continues to create challenges for allocators, schedulers, officials-in-charge, and organizers from all facets of our game. I'm tremendously proud of the smaller-than-normal group of officials who continue to step up to make sure most games were covered. But we were stretched, leading to burnout, stress, impacts to consistency/quality, and teams seeing the same officials consistently. This is not ideal for the health of our sport.

Speaking with other provinces, I can safely say we continue to manage this challenge with innovation and creative thinking that led to fewer games being cancelled relative to what we saw in other provinces (notably Alberta, Ontario and Quebec). In part, this is due to the incredible efforts of our allocators – Ashley da Silva (Lower Mainland and Interior/Okanagan) and Serena Boyer (Island). We had several long weekends in June and July where we really should have cancelled more games but with creative assigning, we were able to miraculously cover games. We were forced to reschedule only eight games (primarily Junior B Tier 2 on the mainland) provincewide (and with minimal impact to travel teams as promised in Whistler). We also only had to reschedule one game in North Shore this season which is a massive improvement on the 10 rescheduled in 2023.

As noted in my chair report last season, we continue to need a long-term solution for referee recruitment and retention. Abuse continues to plague our indoor game, and we also face a labour-market challenge in retaining officials who are lured away by jobs with higher pay, less abuse and more flexibility in hours. Referees are also in a position now where they are trying to create balance in the summer with year-round lacrosse officiating creating the need to recharge during the summer. We continue to seek long- term solutions focussed on ongoing improvements to pay, travel, scheduling and accountability for abusive coaches.

Pay, in particular, is something we're going to need to enhance to continue to keep officials in a spot to prioritize officiating over other hobbies/activities.



While referees are the only people in the sport receiving compensation, this is consistent with what we see in other sports; however, lacrosse officials continue to fall behind what we see in other indoor contact sports and we need to do a full review and adjust to match what we see elsewhere and build in increases to remain competitive. Alberta and Ontario offer compensation gains through travel that helps to bolster game fees. We are still lagging far behind other jurisdictions in this regard.

To help the senior officials pool to grow, we need to work effectively on a graduation program for topend minor box lacrosse officials. A regional approach (similar to Ontario's Qualifier program) should be considered between Western provinces (B.C, Alberta and Saskatchewan, possibly Manitoba) and venues could rotate (B.C. in Year 1, Alberta in Year 2, Saskatchewan in Year 3) at major tournaments (think the Wingrove) – you could include three-ref mechanics here and on-floor sessions leading into the events. I believe this is crucial to long-term recruitment and retention and I'll be putting a funding proposal together for discussion at the AGM in the recruitment/retention session.

I'm proud of our representation of officials at the national level. I'd like to publicly acknowledge our senior box lacrosse officials for national, international and major events in 2024:

- · Mann Cup Lee Brien, Tim Carlton
- Minto Cup Cameron Anderson, Nico Beaudoin, Riley Lo, Nick Thomas, Ryan White (OIC Andy Watson)
- · President's Cup Vince Burelle, Nathan Chiasson, Nicholas dos Santos, Jason Syrotuck, Braden Wilkins (OIC Sean Lehman)
- · Founders Cup Josh Beauregard

I'm also proud to note B.C. had the most representation nationwide at national and world lacrosse events in box lacrosse this year (for the World Box Lacrosse Championships in Utica in September, we had 13 officials selected to represent the province on floor: Cameron Anderson, Vincent Burelle, Nathan Chiasson, Nicholas Dos Santos, Keith Gagne, Jacoby Krassman, Angie Reid, Jason Syrotuck, Nick Thomas, Ryan White, and Braden Wilkins (Ashley da Silva and Riley Lo had to decline due to work), and I was named as a deputy official-in-charge with the leadership group.

For 2025, I recommend the following focus areas for the new vice-chair of senior officiating:

- **Retention of officials:** pay, travel and recognition will be focal points.
- Recruitment of new officials to senior lacrosse: in particular, how do we recruit adults
 graduating from senior leagues to be able to help support us (can move them into Senior C and
 top minor more quickly than a teenager given their transferrable work skills and gameunderstanding).
- Recruitment of female, Indigenous officials: With the growth of the women's game at the international level, we are lacking a pathway for female officials to be successful and must create a plan. We also lack Indigenous officials in our sport and must look at finding ways to recruit and retain officials who identify those officials.
- **Year-round education:** focus on influencing at the national level on training, educational and information resources; enhancing our clinic for L3-5 referees in indoor/outdoor lacrosse.



- **Centralized provincial assigning:** There needs to be better alignment with all leagues year-round to help with assigning. There were some gains made this year but a new assigning software (Ramp) took away the ability to do this effectively with many gaps found in the software.
- **Professional development and recognition**: We must build more reciprocal relationships with non-BCLA leagues to allow for long-term officials this includes the ALL, World Lacrosse, the National Lacrosse League, US Lacrosse and the National Collegiate Box Lacrosse League. These leagues offer year-round development opportunities which can benefit our officials and give them additional exposure and opportunity for recognition outside of B.C.

A special thanks to Deb, Dave, and Jill at the BCLA Office (along with Shannon who was great in her short time in her role). We are incredibly grateful for the support and coordination from our PSO team. Like the volunteer portfolios building up, the office has way more on their plate (this will continue to shift in years ahead as the Olympics are on the horizon). The office could use additional staffing support and I am hopeful there are funding opportunities to assist them in this regard. We could benefit from oversight of administrative tasks (more hands on support at weekend clinics; payment collection; support with systems etc...) but the staff is already stretched too far and it would be unfair of us to ask for additional support. Next time you see these folks, say thank you. They are critical to the functionality of our group.

I'm looking forward to seeing some new ideas and momentum come to fruition for the 2025 senior box lacrosse season with a new vice-chair of senior; I will be there to support them in transition.

I am confident in the leadership group that will be in place to continue to move things forward. In particular, since taking on this role, I'd like to thank Doug again for his advice, patience, guidance and candor.
