# BC LACROSSE ASSOCIATION 2025 PROPOSED CHANGES TO THE BCLA GENERAL OPERATING POLICY

# Proposed by Doug Wright, BCLOG Chair

To alter all references in the BC Lacrosse Operating Policy as follows:

<u>Background:</u> Some references within the Operating Policy of the BCLA and British Columbia Lacrosse Officials Group reference the BC Lacrosse Officials Technical Support Group but then references that group as the BC Lacrosse Officials Group. For ease of reference we should ensure this is uniform. As a housekeeping I would amend as follows:

To confirm and alter any and all references in the BC Lacrosse Operating Policy to the British Columbia Officials Group, British Columbia Officials Technical Support Group, British Columbia Lacrosse Officials Group, British Columbia Lacrosse Officials Technical Support Group to be the **British Columbia Lacrosse Officials Group** ("BCLOG").

<u>Rationale</u>: It is felt that BCLOTSG is unnecessarily wordy and overly complicated. This motion is to both simplify and ensure consistency throughout policy.

# **REGULATION 3: FINANCING 3.04 currently reads:**

3.04 Based upon the budgets prepared, the Vice President - Administration and Finance shall recommend to the Annual Meeting the registration fees required for the coming year as outlined in <u>Appendix B: BC</u>
<u>Lacrosse Registration Fees.</u>

# Amend REGULATION 3: FINANCING 3.04 that would read:

3.04 Registration fees shall be set by the Board of Directors, in consultation with the Finance Committee and the Executive Director and shall be set no later than 4 months prior to the start of the respective lacrosse seasons. (Box, Field, Sixes)

#### Rationale:

This allows the organization to keep pace with inflation and adapt to fee increases imposed by Lacrosse Canada. The current process of setting fees at the AGM means that the Field Lacrosse season operates on "last year's" fee increase which doesn't allow for the addition of events or take into consideration cost increases that may have occurred in the months following the AGM (October) and the start of the next Field Season (September of following year). We are also at the mercy of Lacrosse Canada changing its registration fee after we have had to put forward to members our proposed registration fee increase, leaving the Association in a deficit situation.

# **DELETE REGULATION 3: FINANCING 3.05 currently reads:**

3.05 Any changes in registration fees must be made by a resolution in accordance with By Law XX, Section 3.

**Rationale**: Bylaw XX has no section 3. I believe the referred Bylaw XX Section 3 was meant to be Bylaw XX1 Amendments to the Constitution and Bylaws Section 3. This is a simple typo that would require a housekeeping change.

However Bylaw XX section 3 revers to the mechanism for "AMENDMENTS TO THE CONSTITUTION AND BY-LAWS". It has no mention of changes to Policy. Registration Fees are in Policy, not in Constitution and Bylaws.

# **REGULATION 7: PLAYER REGISTRATION 7.02 currently reads:**

7.02 All Minor/Youth players (Box/Field) must register within the set boundaries (a primary residence within a city, town, municipality, school district, etc. of the appropriate Directorate as determined by the specific Commission/League.

# Amend REGULATION 7: PLAYER REGISTRATION 7.02 that would read:

7.02 All Minor/Youth players (Box/Field) must register within the set boundaries (a primary residence within a city, town, municipality, school district, etc. of the appropriate Directorate as determined by the specific Commission/League. Associations that register any players outside their set boundaries will be fined \$500 for each improperly registered player. Accepted documentation of proof of residence is outlined in Minor Directorate Policy 8.01.

<u>Rationale</u>: There are associations that are losing access to players within their jurisdiction and boundaries to associations that have accepted a registration without knowing the set boundaries or requesting proper proof of residence. This will put some pressure on association registrars to be more diligent in reviewing player registration information.

# **REGULATION 26: AMENDMENTS 26 currently reads:**

- 26.01 The General Section of the Operating Policy shall *not* be altered *except* at the BCLA Annual *General* Meeting and shall be made *only* by *a majority vote of the members voting thereon*.
- 26.02 Notice of the proposed amendment shall be given in writing to the BCLA Office at least forty-five days before the day of the *Annual* Meeting, and the proposed amendments shall be circulated to the members at least thirty days prior to the *Annual* Meeting.

#### Amend REGULATION 26: AMENDMENTS 26 that would read:

- 26.01 The General Section of the Operating Policy shall be altered at the BCLA Annual Meeting or properly constituted Special Session. Changes shall be made by an Ordinary Resolution.
- 26.02 Notice of the proposed amendment shall be given in writing to the BCLA Office at least forty-five days before the day of the Meeting, and the proposed amendments shall be circulated to the members at least thirty days prior to the Meeting.

<u>Rationale</u>: If something unforeseen happens, the BCLA may need to open the policy regulations with members to deal with an issue or changes in landscape or similar.

It is very difficult to change when the change is only able to happen once per year.

Rationale: The fees charged by the BCLA make up a significant portion of the Association's revenue and so on the advice of our accountant this proposal includes an increase to fees, across the board, by approximately 15%. Members have been asking for additional services and events and we need to find a way to pay for those, U11 Field Provincials as an example. Lacrosse Canada has also increased its member fees and we have not kept pace. The LC fee per Official is \$25 and per Coach

\$20, for some time now, BCLA has been charging Coaches \$10 which means we're creating a deficit. Our hope is that these increases ensure we aren't creating deficits and that with a slight increase in funds we can offer members the services and events they want.
