- *The Registrar shall appoint assistants as needed.*

The tournament Host Co-ordinator will contact them to deal with any situation where a potential suspension exists. The Tournament Commissioner will administer the discipline for tournaments, and will do so using the Field

Directorate Disciplinary Rules for the current playing year; and will ensure that disciplinary action is consistent with that administered during league play.

**Amend REGULATION 7: TOURNAMENTS 7.03 that would read:**

- 7.03 A Tournament Commissioner must be assigned by and confirmed with League Chairs for each sanctioned tournament from the pool of ratified League Commissioners by October 1. The tournament Host Co-ordinator will contact them to deal with any situation where a potential suspension exists. The Tournament Commissioner will administer the discipline for tournaments, and will do so using the Field Directorate Disciplinary Rules for the current playing year; and will ensure that disciplinary action is consistent with that administered during league play. **Any suspensions that are handed out for play in the tournament must be copied to the Vice-Chair of the respective sector.**

- 7.04 No more than two games per calendar day will be scheduled for each team during tournament play. But teams may play up to three modified or mini games (~~two halves only~~) during tournament play per calendar day. No player may play in more than the maximum number of games. A copy of the tournament schedule must be submitted to the Field Directorate.

U7 – 4 x 8 minute quarters maximum (32 minutes)

U9 – 4 x 10 minute quarters maximum (40 minutes)

U11/U13/U15/U18/Men's – 4 x 12 minute quarters maximum (48 minutes)

If the tournament organizers choose to play halves instead of quarters, the total number of minutes played per game may not exceed the above totals per game.

**Amend REGULATION 7: TOURNAMENTS 7.04 that would read:**

- 7.04 No more than two **full** games per calendar day will be scheduled for each team during tournament play. But teams may play up to three modified or mini games during tournament play per calendar day. No player may play in more than the maximum number of games. A copy of the tournament schedule must be submitted to the Field Directorate.

**Mini-Games are as follows:**

U7 – 4 x 8 minute quarters maximum (32 minutes)

U9 – 4 x 10 minute quarters maximum (40 minutes)

U11/U13/U15/U18/Men's – 4 x 12 minute quarters maximum (48 minutes)

If the tournament organizers choose to play halves instead of quarters, the total number of minutes played per game may not exceed the above totals per game.

Overage players shall not be eligible for tournament play unless the overage player is a registered member of the younger team and has been sanctioned by the player's home association League. No player may play in more than ~~two (2)~~ **games** per calendar day by playing on different teams.

- 7.05 In all leagues for tournament play, only players who are of the appropriate age to play in the specified divisions, or players younger than the appropriate age, may compete. - 11.04 Exceptions to specific Field Directorate Operation Regulations may be considered by the Field Directorate Executive. Exceptions will be temporary in nature, decisions will be made in the spirit of fairness and with competitive integrity to these policies under exceptional circumstances. The duration of these decisions no longer than the end of the current or upcoming season. Exceptions must be passed by a majority vote of the Field Directorate.**

**Rationale:** Based on a recent appeal, the Field Directorate received recommendations from the appeal committee to add in a regulation that could allow the Field Directorate to make decisions that would be in fairness and spirit of competitive integrity under these policies in exceptional circumstances.

Also required is a team list generated from the on-line database and any applicable signed supporting forms (Player Transfers, Playing Down forms) and required fees to the BCLA Office by October 31 of each playing year (Sept-Aug).*~~
- (b) ~~*Each Association will submit to the BCLA Office, prior to October 31 of each playing year, a team list generated from the on-line database for each team in the Association. One hard copy of each manual registration and waiver form is required with the Team List (it is not necessary to print/submit copies of the on-line registrations). The manual player registration form must be signed by the parent/guardian and the Association Registrar. Failure to comply with said dates will result in the offending Association to be fined \$250.00 and another \$250.00 for each additional seven-day period that the registration forms are not received. For any subsequent paperwork corrections required by the Field Directorate Lacrosse Registrar, this must be submitted by December 1 of the playing year or the Association's team(s) will be unable to declare for Provincials.*~~

**Amend REGULATION 13: YOUTH PLAYER AND COACH REGISTRATION 13.05 (a) (b) that would read:**

- 13.05 (a) **Each Association will submit to the BCLA Office or email to the BCLA Registrar by Oct 31 of each playing year, a Summary Sheet (provided by the BCLA Registrar) of number of players, by Division / Tier / Team generated from the on-line database. One copy of each manual registration and waiver form is required to be emailed to the BCLA Office. Also required are any required fees to the BCLA Office by October 31 of each playing year (Sept-Aug).**
- (b) **Failure to comply with said dates will result in the offending Association to be fined \$250.00 and another \$250.00 for each additional seven-day period that the registration forms are not received. For any subsequent paperwork corrections required by the Field Directorate Lacrosse Registrar, this must be submitted by December 1 of the playing year or the Association's team(s) will be unable to declare for Provincials.**

**Rationale:** This change is housekeeping. I no longer require Registrar's to send in Team Lists but instead have them complete a Summary Sheet. I then go into RAMP and vet the registrations / comparing what is there with what is on the summary. Emails are also now accepted, where in the past it was all by post.

- 13.07 (e) To register these late players, the association will obtain approval from the League Commissioner. ~~*The Association Registrar or the League Registrar will provide an electronic copy of the registration to the Field Directorate Registrar supplying the player's name, address, birthdate, medical number, insurance waiver, and applicable team information. The Field Directorate Registrar will add the player's name to the appropriate team list and update the registration database. Within five (5) days, the Association Registrar or the League Registrar will provide to the BCLA Office the original registration forms.*~~

**Amend REGULATION 13: YOUTH PLAYER AND COACH REGISTRATION 13.07 (e) that would read:**

- 13.07 (e) To register these late players, the Association Registrar will get approval from the League Commissioner **and will email that to the Registrar of the Field Directorate, along with supplying the player's name, address, birthdate and applicable team information. The FD Registrar will add the player's name to the appropriate team list and update the registration database.**

**Rationale:** This is the process that has been in place for some time so this is just housekeeping.

When traveling out of BCLA governed areas, teams must adhere to host governing rules as well as the BCLA Policies.

**Amend REGULATION 21: YOUTH PLAYING RULES 21.02 that would read:**

- 21.02 The Field Directorate will instruct member associations they must adhere to the World Lacrosse rules **or what adaptations the BC Field Directorate implements**, LC rules, **or what adaptations the BC Field Directorate implements**, and policy, and to the BCLA Field Directorate Operating Policy as written.
- When traveling out of BCLA governed areas, teams must adhere to host governing rules as well as the BCLA Policies.

**Rationale:** To give the Field Directorate the opportunity to adapt the game to the players of British Columbia.

**REGULATION 21: YOUTH PLAYING RULES 21.03 currently reads:**

- 21.03 ~~*Where there are two teams from one Association playing in one league, there is to be no movement of players from one team to another, and back and forth, after October 31 of the playing year. If said infraction occurs after October 31 of the playing year, the player would be eligible for the player's registered team only.*~~ Any team found guilty of playing an ineligible player during a regularly schedule game shall forfeit all games won during which an ineligible player was a participant. Should this occur in the playoffs, then, only the games played in the playoffs will be awarded to the opposing side.

**Amend REGULATION 21: YOUTH PLAYING RULES 21.03 that would read:**

- 21.03 **Player Movement – Playing up in calibre U11 and Up**

**Where an association declares more than one team within the same age division players may be permitted to play up in ranking to support development and roster needs. After October 31<sup>st</sup> under no circumstances may a player from a higher-ranked team play down to a lower-ranked team.**

**Example:**

**Within the U13 division, a player rostered on a U13 Ranking 2 team may be called up to participate with a U13 Ranking 1 team when required. However, a player rostered on a U13 Ranking 1 team is not permitted to play down to a U13 Ranking 2 team.**

**Any player participating in games at a higher ranking may do so for a maximum of five (5) games. Upon exceeding five games at the higher ranking, the player will be considered a permanent member of the higher-ranked team and must be rostered accordingly.**

If a team withdraws from participating in the Women’s Provincial Championship after declaring, the parent club shall be subject to a **\$1,000.00** fine per team that withdraws. Additionally, if a team withdraws within 14 days prior to the start of the Women’s Provincial Championships, the parent club shall be subject to a \$3,000.00 fine per team that withdraws. If a team withdraws from a Provincial Tournament after declaring, the parent club shall be subjected to a \$500 fine per team that withdraws if that team withdraws less than 14 days prior to the start of the tournament. Outstanding fines not paid by the first day of registration of the following season will result in all player registrations for that association to be suspended until the fine is paid.

The registered player names recorded on the declaration form will form the final roster for Women’s Provincial Championships and the only changes permitted will be to delete registered players who will not be participating due to not meeting qualification requirements, injury, etc. or to add any call-up players who have played a minimum number of games in the league to meet the qualification.
