# 2024 Minor Directorate Special Session October 19, 2024 BCLA Minor Directorate Chair Report: Gord McIntosh

As we enter our box lacrosse off-season, we can look back and see some positive signs as well as some challenges. We have areas where registration has grown significantly. This is usually due to specific efforts by the local association to expand or introduce box lacrosse to the local communities. We also have areas that have not been able to recover from the break we experienced from 2020/21. Female box has been and continues to be an area of growth. Having an interlocking league schedule between the lower mainland and Vancouver Island will help grow and develop the Island female program. The lower mainland teams have been helpful in making this work. It isn't perfect yet but each year we will work on this to make it better. While I had reported in 2023 that Lacrosse Canada was going to make some rule changes on off-ball contact, this has been frustratingly slow to get implemented. With the 2024 summer Olympics completed, we look forward to the 2028 Olympics in the US and the introduction of sixes as an Olympic sport. Preliminary plans are being worked on and we can expect to see more of this in the next few years. Discussions are ongoing on how to fit this into our current box and field schedules. Tournaments were back to almost pre-2020 levels, which is encouraging. Some divisions had few options, which has not occurred before. While the coach's group has shown strong leadership in dealing with coaches and verbal abuse of officials, we are hearing of how difficult it is to deal with parents and families for individual associations. This includes abuse of officials from stands, abuse and harassment of association executive and just overall poor behaviour. Social media use to air comments/complaints is another source of aggravation. We need to provide associations information on what to do and how to deal with these parents and families. Association executives are volunteers that are not qualified or comfortable in most of these situations. They need some support. While we have strong numbers for officials for U7-U11, we struggle keeping our late teen and young adults as officials. While this is a time where they become busier themselves with work and school, the abuse they take from the stands and coaches is usually a determining factor in them deciding to leave our game.

We had another successful run of provincial championships in 2024. There were 4 provincial championships hosted on 3 weekends in July. The BC Summer Games took place in the middle of our provincial championship season, so we had to take a break for 1 week in between. Our provincial championship hosts did a wonderful job, and we thank them very much for stepping up and allowing us to put on the provincials. It was good to see updated banners, championship plaques and the sport socks for player of the game winners.

We were disappointed to hear of the changes to our AGM. We received full disclosure why the need for the change and appreciate the reasons why this has occurred. We hope that it doesn't greatly effect attendance at our meeting in October.

There are 19 people (18 now, as we have 1 zone rep vacancies) that make up the Minor Directorate and I thank each one of them for their time and dedication to lacrosse in BC. They have been a patient and supportive group to work with and always have a view to what is best for lacrosse in the province, not just their league, zone, or commission. With the exception of our August meeting, all our MD meetings were held at the BCLA office, and it led to more interactive and effective discussions.

Thank you to the BCLA staff of Jill, Dave and Deb in helping me get through another box lacrosse season as minor directorate chair. You are a treat to work with and we appreciate your efforts. While being short staffed for most of the year, they were able to provide us with the same level of support we have always had.

This was in addition to advance notice of the deadline send in mid April and at the beginning of May. Some never did submit their required supporting paperwork. Unfortunately the time required to get this information adds up very quickly.

Of enormous benefit again this year were the spreadsheets from the Commission Chairs sent with their approved Player Transfers / Oversized Teams / Playing Down Approvals. This helps to move everything along at a much higher pace. A grateful thank-you to those Commission Chairs that sent theirs in, supporting this process.

#### The 2024 Box Lacrosse season for Zone 2 was one of growth:

- Girls' participation grew, not enough to take part in the Provincials but with a positive look forward something that is not unattainable in the future.
- Tournaments held by Kamloops, North Okanagan, Kelowna, and Penticton were well attended

#### The zone also experienced some challenges:

- Nicola Valley, Logan Lake, and Princeton we unable to field teams this year
- Shuswap is in a rebuilding stage with U7, U9 and U11 teams
  - Loss of facility space due to ice plant issues impacted access to dry floor until May. Loss
    of space impacted registration as no confirmed arena practice space.
- Officials were again stretched, with associations having to pay large sums of travel funds to have games covered at all levels. The failure to plan clinics prior to the season, and the last-minute nature of the clinics was extremely detrimental to the officials available in the interior. Clincs were held prior to the season and throughout the season in the lower mainland and the island opening up more options for areas that span as great a distance as the Interior (as well as the north and Kootenays) is imperative. There is a difference between attending a last-minute clinic 20 mins away and one that is 200 kms away.
- Coaching clinics were unfortunately the same mis-mash of delivery. Pop up clinics with one week of confirmation no solid communication to the clubs. Receiving emails about the clinics in Vancouver when they are posted but the same consideration does not happen outside the region.
- Parents in the stands were a challenge at one point, swift and commission wide action and support was implemented and the issue was not replicated again in the season.

#### The 2024 season was one of success at the Provincials for the region:

- Penticton earning U17B Gold, U15A2 Gold and U13B Silver
- North Okanagan earned U13B Bronze
- Zone 2 swept the U13C Provincials earning Kelowna Bronze, North Okanagan Silver and Kamloops Gold
  - O The Kamloops team did not win a league game, failed to win a game in the Provincial Playdowns, lost the wildcard game for placement in the 13C division. And with 4 U11 callups (including the goalie) proved why you show up for practice everyday and never give up on yourselves went undefeated in the U13C division to earn the gold.
- North Okanagan Minor Lacrosse was given the opportunity to host the Provincials again, U13
  this time. Again, they did an amazing job. One issue that actually is a learning lesson for
  Provincial hosting moving forward, the volunteers did a fantastic job communicating and
  ensuring representation for all teams. Thank you!

MD LMMLC Year End Report – 2024 Respectfully submitted by Sandra Margetson

The 2024 box lacrosse season was as busy as it was challenging.

Lmmlc had a number of combined teams this season, and as stated in previous reports, we will need to solidify the parameters under which we allow associations to combine and where they declare. It has been discussed that we need to have continuity among the zones regarding how we approach combined teams. This needs to happen, and an agreement needs to be established before the start of the 2025 box season.

Tiering was a major issue. We reset points to zero after tiering in an effort to clarify standings for the end of the year but re: tiering teams and interlocking A divisions made it difficult regardless. The policy will need to be updated to create more transparent procedures.

The need for a revamped tiering system or eliminating it altogether has been broached by the LMMLC executive as well several Presidents & coaches.

We are confident a solution can be agreed upon well before next year and look forward to working on this with the respective parties involved in the off season.

LMMLC appointed a Head Commissioner this year to help with communication with teams and mentor the new club volunteers. I would like to thank the commissioners who returned from last season and the brave new ones who took up the challenge of being division commissioners.

The female interlocking agreement continued this season between the Island and the Lower Mainland. The main issues on the need for more floor time on the Island, the communication between team managers, commissioners, teams not going to the Island due to missing players on weekends (top reasons - pay to play programs, team BC) all had an impact. The plus side is tiering, more games and growth overall.

We had an increase in age down requests as well as releases this season. In particular the U 22 female division all had the need for oversized rosters due to the number of releases, many of them arriving after declarations and after the season was well underway.

We had a large increase in player hearings, a few repeat offenders this year as well as several concerning situations involving officials, spectators and coaches.

It remains disheartening that the overall message regarding codes of conduct and respect are not getting through.

I had the pleasure of being the Supervisor for the U 17 youth Provincials in Langley July 25-28th. The event itself was well organized but the distance between the two arenas LEC and Aldergove strained the volunteers and separated the teams  $\,$ . The issue of spectators misbehaving, highlighted the need for security especially in this age group.

I would like to thank the LMMLC executive for their many, many hours of volunteering, over and above what they may do for their home associations. Also, thank you to the LMMLC Association Presidents for their input, suggestions and ideas that helped make this year a success.

I still maintain due to the growth of the female divisions, it is becoming apparent there may be need for 3 divisions within each age group as there appears to be A teams and B teams and clear C teams. In order to grow the sport in the female category, my hopes are this is evaluated and considered for next season.

BC Summer games were a hugh success with a very close battle for gold between Zone 3 and Zone 4. A single goal separated the winner with less than 1 minute left in the game. The biggest thing that came from these games was the celebration of sport. It appears all players involved were having a safe respectful and "clean" way of playing. My hopes are we can harness this energy and take that forward in our future regular seasons as every fan I spoke to said it was the best lacrosse to watch as everyone was playing the game for the game.

Lastly, I was able to participate as an MD representative in the Female Provincials in Port Coquitlam and the U17 Provincials in Langley and I am incredibly impressed with both groups. The volunteers were relentless in ensuring a perfect event went on and the facilities in both areas were fantastic. Some incredibly awesome games were played and few incidents throughout. Thank you to Port Coquitlam and Langley for hosting these events. This is what makes lacrosse incredible.

#### Zone 5 Provincial results:

11 Teams competed across 4d Tournaments with 7 Teams having medalled (4 of these were combined)

Tournaments hosted in Zone 5 were the Sid Dann U13 in Vancouver, the Roadrunner Spring Classic for U17 May 22nd - 25th and the Salmon Festival (U11 and U9) June 15th - 17th, both in Richmond. The Jack Crosby in July in Burnaby.

Feedback from associations was mostly comments about the tiering decisions and how they would like more transparency regarding the reasons for these decisions. It is understood that it is not a perfect system, and that we are spending more time on it......(they say some decisions just didn't make sense) Same can be said for releases and that process.

Some other re-occurring comments/concerns that have filtered back are:

- Volunteer pools continue to shrink need sharing of best practices to recruit and retain.
- Growth in referee numbers (younger ages) has been great. I would like a plan to help with the retention of these so they stay long-term.
- Some frustration around Team BC, Fusion and other programs having events during Box season, especially playdowns.

The feeling around the Sport is of excitement. The level of play has definitely been raised. The combination of associations to push play-up has been welcomed and supported.

The growth of the Female divisions has been amazing.

A buzz around the Olympics has started.....the 6's format creates another reason to play. I'm excited to see how it plays out over the next couple of seasons.

To better mitigate against spectator behaviour, we have passed bylaws giving power to the commission to ban spectators and enforce disciplinary actions against spectator behaviour.

Our development divisions had a lot of fun and it is great to see lots of new participants – particularly in the mini tyke and tyke divisions. Our competitive divisions had a great season and a number of Island teams qualified for Provincials with the following teams winning medals in Provincial play.

# 2024 Year End Report Vice Chair Minor Directorate

The 2024 Box season wrapped up with four Provincial Championships hosted in the Lower Mainland, the Okanagan and on Vancouver Island. The three **Mixed** divisions had a combined **72** teams competing while the **Female** division had **37** teams competing which equaled **109** box lacrosse teams participating in our Provincial Championships. We are still waiting on some documentation and invoices from some hosts and supervisors so I cannot speak to the financial aspects at this point. We experienced some challenging situations as well as suspensions to players and coaches, but through our Commissioners, Coaching Representatives, OIC's and Minor Directorate personnel, all situations were managed effectively with a few outstanding hearings to come because of the recent U17 Provincials.

#### **U15 Provincials Comox July 4-7**

Big shout out to Host Director Heidi Grootendorst and her team of highly motivated volunteers. Tim Frost served as the Supervisor with Brande Terris as the Liaison. This combination developed a highly effective system that addressed all challenges and provided key oversight. Doug Kampen was invaluable as the experienced Commissioner. Dan Chetner and Kelly Fines worked together to cover all aspects under the Coaching Representative umbrella. OIC's Tyler Boyer and Vince Steigel were extremely professional in their roles and provided an elevated level of officiating structure. Michael Hagel also was in attendance and provided much needed assistance when his son's team was not competing. Comox Valley Lacrosse Association should be commended for their successful Provincial Championship

#### **U13 Provincials North Okanagan July 11-14**

#### Issues from this season:

We need to manage tournament a little closer.

- It is a free-for-all in how applications are made.
- There are different people from the same team applying for the same tournament
- There are association contacts applying instead of teams
- There are people applying for WAY to many tournament
- X Some tournament coordinators wait to long to get confirmation from teams.
- Most tournament coordinators don't inform applicants that were not selected in a timely manner.

It is too easy to apply, you don't even have to be from the team and you don't need to know if the team will even attend if selected. We need rules around who can apply and how many they can apply for. Teams need to be willing to attend every tournament they apply for.

1. Teams and association applying for way too many tournaments

We had several individuals that applied for all the teams in their association.

There were several examples of one person applying for many teams for all tournaments possible. And several examples of teams applying for every tournament even though they will only attend one or two.

This makes it verry difficult for the tournament coordinators. The contact info from the person that did the applications is not the contact for the respective teams so it is very hard to make contact with the teams.

Also, a new coordinator thinks they have a huge number of applicants to make the tournament viable. We need to make it so that teams only apply to the tournaments they are willing to commit to patriciate in.

There should be no applications for a tournament from anyone other that a Team Coach or Team Manager and even then, only after a team meeting so everyone is committed to participating in the tournament(s) that are applied for.

# <u>Teams should only apply after they have beam formed and there has been a team meeting and the parents and coaches all support the tournament application.</u>

2. Tournament coordinates waiting to long to confirm teams

Tournament coordinators need to accept teams earlier and then reach out to teams that applied and were not accepted.

3. Adding tournaments part way through the season

We added a couple tournaments part way through the season. This was done to accommodate some teams on the lower mainland that were not accepted into any tournaments.

It was the right thing to do but does present some problems. It is not fair to all teams to add tournaments late in the season that are not advertised the same as all the others.

Many teams did not know these tournaments were added and so they did not get the opportunity to apply. These tournaments were not all added to the database so they can't be tracked properly. It was not clear how teams (and what teams) were made aware of these added tournaments.

When we add tournaments part way through the season they do not get the same level of scrutiny as when the Minor Directorate vets them as a group.

4. The fine is too low for team bailing on tournament games

We had two teams bail on a tournament game. They just chose not to play it as it would not change their placement in the tournament. The teams were fined but in my opinion, the fine is way to low. When you divide the cost of the fine between the families on the team the cost is insignificant. The fine needs to be raised.

Need better business rules around the form for applying to host a tournament.

The business rules around filling out the application to host a tournament need to be improved so that the metrics are easier to present. I will work with our Database Administrator to improve the application to apply to host a tournament.

I first off would like to thank all the people involved in the Coaches Technical support group and the BCLA office for all the work they do throughout the year

This season once again brought out allot of craziness with all involved ...Player, Coaches, Officials, Parents, Association Presidents. We had coaches still thinking it is ok to swear at officials, parents drinking in the parking lots and yelling, swearing and fingering minor players and officials. I will say that this is the first season since I have been in this position that we have not had to do a hearing for a coach in minor. As a sport we still have a great deal of work to do and it has to happen sooner rather then later of there won't be anyone to play this game. It is time that associations start to deal with their own problems instead of pushing it off to the BCLA and all the executives.

The Coaches Technical group is always looking for more clinicians especially in all the areas outside the lower mainland. I would ask all clubs to look for someone in your own association that may want to do this so we can have more clinics and be able to train more coaches.

This year we held 26 clinics for Community Development-Level 1, We had 418 people attend and 64 no-shows. We had 16 clinics for Competitive Introduction-Level 2 with 190 attending and 19 no shows. I will be recommending to the office it is time for these clinics are paid for up front. We need associations to take more responsibility for their coaches training to make sure coaches have the proper training before it becomes too late in the season. Most associations have no idea if a person has any training till it is told to them half way through the season.

I would like to thank all the host clubs that took on all the provincials and Summer Games this season, and a huge thank you to all the volunteers that spent many hours of their time to make them all successful

#### 2024 - Vice-Chair Minor Box Officials - Year-End Report

The 2024 lacrosse season was marked by both challenges and successes. A key issue we continue to face is the severe shortage of referees, especially in the higher divisions. Our Level 2 referee numbers have been steadily declining for several years, and unfortunately, this year was no exception. As I mentioned last year, "Without a new way of thinking and doing, we will continue to do the same thing, get the same result, have the same conversations, and wonder why things are not getting better." This sentiment remains true today.

After interviewing several officials who have left the ranks and are not returning, one common theme emerged: the culture of constant debate about "how much will or should we tolerate," the leadership driving abusive behavior, and the structural and political issues within the program. These factors have made it increasingly difficult to retain officials.

I was elected by the Officials Technical Group to bring about change, and I firmly believe that cultural transformation is crucial for any positive developments. However, not everyone is open to change; in fact, some are vehemently opposed, clinging to an outdated, club-centric system. This year, I encountered resistance from club presidents questioning the Officials Group's right to communicate with "their" officials, from Head Referees—who were elected by their clubs—about what uniforms "their" officials could wear, and from allocators, many of whom are not qualified officials, questioning their ability to assess an official's performance. The challenges seem endless.

Clearly, the traditional methods are no longer effective. Another significant challenge has been finding the right support for officials, rather than the support they currently receive. While we appreciate the 99.9% of members (executive, coaching staff, club-level executives, BCLA staff, parents, etc.) who support the Officials Group, it's imperative to focus that support on what is truly needed. Far too many unqualified individuals are making decisions about officials—decisions that should be reserved for those who are certified through Lacrosse Canada as members of the Officials Group.

This year, the Officials Group implemented a program for assigning officials to ensure that games are officiated by appropriately qualified individuals. We introduced Arbiter in the 2023 season with moderate success, followed by RAMP in 2024, which also saw some success. The reluctance to change—regardless of the system's name—remains a hurdle. However, I am encouraged by the progress made in linking and updating schedules, though there is still work to be done. Each commission (Lower Mainland, Island, and Interior) loads and updates schedules differently, making it difficult for the Officials Group to manage and maintain consistency. I hope we can work with these commissions in the off-season to develop a unified approach.

The integration of a consistent scheduling system is crucial for ensuring that allocators are aware of all games, minimizing scheduling errors. We aim to have all BCLA officials on the same platform, which is especially important for ranking officials by their competency levels and ensuring they meet Lacrosse Canada's requirements. This system also allows for evaluations to be attached to each official, providing valuable insights for head referees, zone representatives, and the Technical Group when selecting officials for Provincials and Nationals. Without this information, we are unable to identify officials for development opportunities.

Currently, club-appointed allocators assign officials, but there is no training for the allocators from an officiating standpoint—only on how to assign someone to a game. I've been informed that club presidents, executives, and coaches have been involved in selecting or approving officials for their games, which perpetuates the notion of "homer" officials. We must do better and eliminate this bias from our vocabulary.

#### **Provincials**

I would like to extend my gratitude to Dylan Taylor and Connor Black (U13), Angie Reid & Sam Patterson (Female), Tyler Boyer & Vince Steigel (U15), and Nico Beaudoin & Braden Wilkins (U17), as well as Doug Wright & Josh Beauregard (Summer Games) for their hard work and dedication in ensuring the success of these tournaments from an officiating perspective. Additionally, I thank all the hosts for their hospitality and care of our officials.

#### Conclusion

In summary, I strongly believe that changing the culture is essential. We need to educate parents, coaches, and officials, and I firmly believe that education is key to addressing referee abuse. We must also leverage available tools to aid in the development of our officials. Our goal remains to ensure that all games are officiated by properly qualified individuals, rather than resorting to unsafe practices just to fill a slot. The decision of who officiates should rest solely with the qualified members of the Officials Group—not with presidents or coaches, whose decisions are often biased and not in the best interests of the game.

Changing the culture of the game is no easy task, and it will not happen overnight. It will not happen if we continue to do things the way we always have. I challenge everyone to take a fresh look at our practices and help initiate this much-needed cultural shift.
